Treasurer</u> (Colleen W): March treasury report was reviewed and accepted unanimously. \$493 total donations/income, \$2479.84 total expenses, which includes 2 \$1000 donations to GSO and Area 48, \$279.84 reimbursement to Gary B for "conference expenses" and \$200 venue reservation fee to Prospect Park (Troy, NY) for the District 2 Memorial Day picnic.
